CONSENT AND RELEASE OF PARTICIPANT

Waiver & release & assumption of risk parental indemnification - in consideration of me or my child being allowed to participate in any IKF Amateur Kickboxing / Muay Thai bout, I agree:

1. I understand the nature of Muay Thai & Kickboxing activities & my experience and capabilities and believe I am qualified to participate in such activity. I agree and warrant that if I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.
2. **I FULLY UNDERSTAND** that (a) IKF (International Kickboxing Federation) activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death ("risks"); (b) these risks and dangers may be caused by me or the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the "releases" named below; (c) there may be other risks and social and economic losses either known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of my participation in these activities.
3. **I hereby release, discharge, covenant not to sue, and agree to indemnify and save & hold harmless** IKF (International Kickboxing Federation) it's officials, representatives, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the activities take place (each considered one of the "Releases" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releases" or otherwise, including negligent rescue operations and further agree that if, despite this release, I, or anyone on my behalf makes a claim against any of the Releases named above, **I will indemnify, save & hold harmless each of the releases from any litigation expenses, attorney fees, loss liability, damage or cost any may incur as the result of any such claim.**
4. I certify that I have had no injuries to my body, whether fractures, broken bones, or otherwise, within the three months prior to this event, and have no injuries to the head, concussion, headaches or fainting spells, and should I experience any of these injuries and conditions **DURING THIS EVENT**, I will immediately notify the officials of the event and cease all participation in the event.
5. I agree that this agreement may not be modified orally and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any subsequent waiver or modification. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
